

## **Church Facility License and Hold Harmless Agreement**

I/We the undersigned authorized representative(s) of (hereafter the "Organization") of the city	
of Oakdale, state of California, desire to license the use of the building and grounds of River Oak	Ĺ

I/We understand and agree that neither the Church, nor its trustees, representatives, employees, and agents may be held liable in any way for an occurrence in connection with the Activity which may result in injury, harm, or other damages to the undersigned or members of our organization and guests, invited or not. Rather, I/We agree that our Organization alone shall be responsible for any property damage, personal injury or death that may occur during our use of the premises.

As part of the consideration for being allowed to license the use of your facility, building and grounds as well as all appliances and fixtures in the activity, I/we release the Church, its trustees, employees, agents, or representatives from any claim for damages, injury or death which may occur while participating in the Activity. I/We further agree to save and hold harmless the Church, its trustees, employees, agents, or representatives from any claim arising out of or participation in any form or fashion in the Activity.

I/we understand the church does not warrant or represent that the property is safe or suitable for the purposes for which it is permitted to be used under the terms of this agreement, and that I/we acknowledge that the church is providing the property and all appliances on an "as is" basis.

If the license to use the church's property and/or buildings involves the participation of minors, I/we warrant that I/we have exercised a high degree of care in conducting background investigations on all persons who will have access to one or more minors to determine their suitability for working with or being present with minors during the use of the property and/or

buildings. I/we further warrant that I/we will use a high degree of care in supervising all activities involving minors during my/our use of the property and/or buildings under the terms of the agreement.

I/we agree that my/our group will be solely responsible for compliance with copyright law during the use of the Church property.

If any products are sold on the premises of the Church, my/our group will be solely responsible for collecting any applicable sales taxes. My/our group will indemnify the church for any taxes it is assessed as a result of my/our group's sales occurring on (or as a result of) its use of the premises.

I/We represent that our Organization has general liability insurance with coverage limits of in effect as of the date of the Activity. I/We agree to name the Church as an additional insured on our general liability insurance policy and shall provide proof of such additional insurance coverage to the Church prior to the date of the Activity.

I/We further state the I/we are authorized to sign this agreement; that I/we understand the terms herein are contractual and not mere recital; and that I/we have signed this document of my/our own free act and volition. I/We further state and acknowledge that I/we have fully informed ourselves of the content of this affirmation and release by reading it before I/we signed it.
